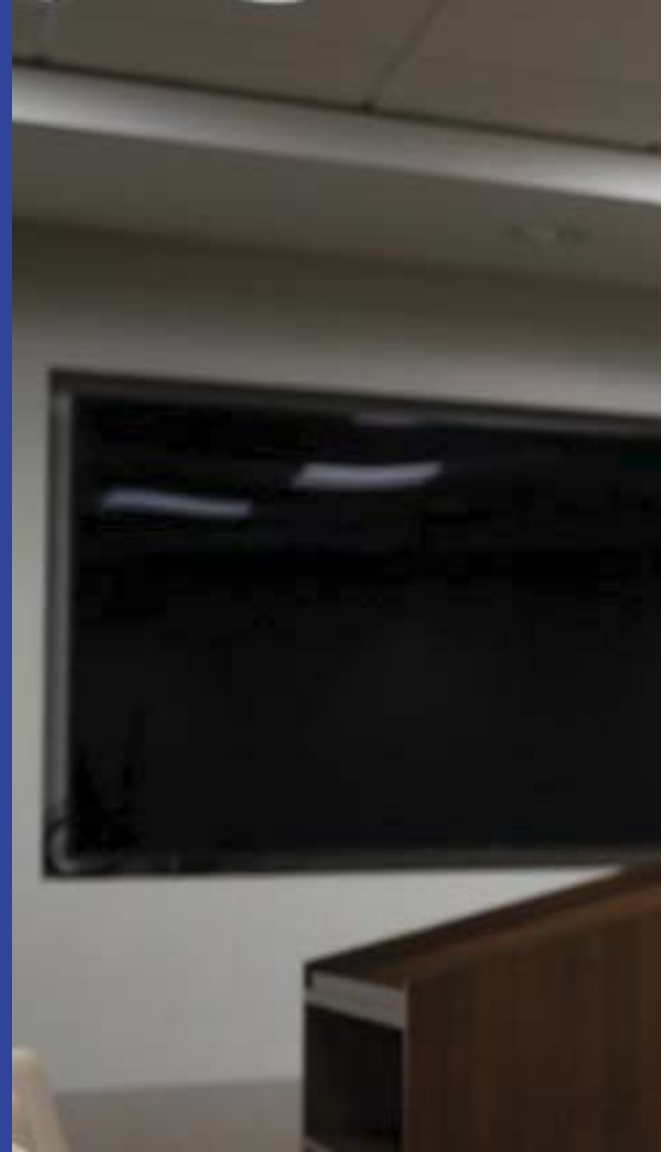

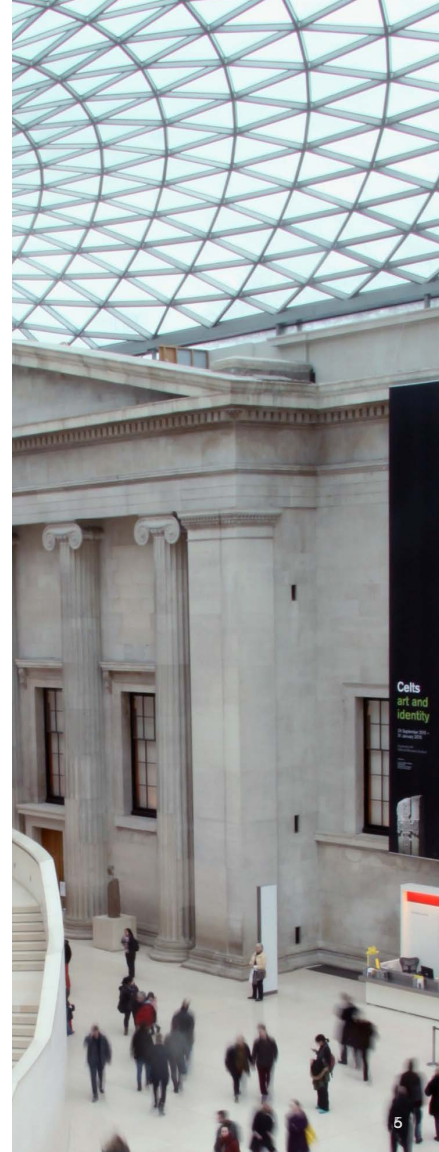
Defective Products
